1. Para- 10

Under sub-head 'For Dental Colleges' at Sr. No. (i), the words "Principal, Government Dental College, Amritsar" are hereby replaced by words "Principal / acting Principal, Government Dental College, Patiala."

2. Para-12

After the first sentence of para – 12, the following sentence is added:  
"In case of private colleges the candidates should have Punjab resident status."



"Provided further that in case adequate numbers of candidates having Punjab resident status are not available even after lowering of minimum marks as above, only then the seats will be offered to other candidates."
