SUBJECT: Admission to B.Sc. Nursing Course -2016 onwards.

In partial modification of Notification No. 5/7/2016-5HB-III/2147 dated 13.05.2016, Para No. 1.3 is hereby substituted as under :-

"1.3 The selection shall be made as per following manner, subject to the condition that the rules / regulations / guidelines of Indian Nursing Council are strictly followed :-

- (i) From amongst the PPMET qualified students on the basis of merit list;
- (ii) From amongst the PPMET appeared students from the State of Punjab;
- (iii) From amongst the bonafide residents of Punjab State on the basis of merit of qualifying exam;
- (iv) If, seats still remain vacant, candidates belonging to other State shall also be considered on the basis of qualifying exam.

However, for the minority quota seats, the inter-se-merit of the candidates of the concerned minority only shall be considered. There shall be no overlapping or bye-passing of inter-se-merit of candidates seeking admission to seats in management/minority quota except NRI quota seats."
