Gist of discussions / decisions :

- 1. Compliance of decisions of Governing Body Meetings dated 28.7.2005 and 25.8.2005:-
 - (i) Release of ACA of Rs. 10 Crores, received by FD in January 2003, held up. Present status of the case not known. Coordinator to inquire and inform. DP to pursue the matter.
 - (ii) Release of Rs. 5 Crores to PAU. Order of the Governing Body under the Chairman be implemented and payment made. Release of ACA should not be linked as a condition to implement this decision.
 - (iii) Release of Rs. 29.96 Crores from PUDA. Communications to SHUD, CA PUDA, CS issued by SMER. Coordinator to follow up. DP should have a meeting with CA PUDA and secure releases.
 - (iv) Vacation of premises of PIMS by PHSC: To be pursued by DP.
 - (v) Exemption from building application fee: No intimation received from Municipal Corporation. Draft DO reminder from CS to PSLG, with copy to PSCM.
 - (vi) Ratification of agreement of M/s Gautam Shah and Associates: Fact sheet containing the details of procedure arriving at competitive architectural fees fixed @4% be brought out by the DP and put up within seven working days to the undersigned.
 - (vii) CM's communication dated 30.8.2005 to P.M. requesting for Longowal Institute Model for PIMS Jalandhar. PM has acknowledged CM's letter, but no "approval in principle" has been received. Draft DO letter (Reminder) from CM to PM; and DO letter from SMER to PRC Punjab New Delhi, enclosing a copy of CM's letter to PM, for following up the matter.
 - (viii) A comprehensive agenda for meeting with PHSC under CS be prepared to decide on items of expenditure on ongoing / essential works within 7 working days as ordered by SMER on 19.10.2005.

It is imperative to have him in the management team to acquire suitable capacity to deal with Consultant and construction agencies, and oversee the construction and facility creation.
- 2. <u>Director Medical / Medical Superintendent</u>: Additional charge can be given to one of the suitable doctors in the Department without any additional expenditure.
- 3. <u>Registrar</u>: Additional charge can be given to one of the suitable doctors in the Department without any additional expenditure.
- It may be worthwhile for the sake of efficiency to maintain a functional work centre / communication office of PIMS at Chandigarh under the Coordinator by sparing a cabin and some of the existing staff of PIMS in DRME Office / Office of SSMER/ SMER.
