**SEATS IN PRIVATE INSTITUTIONS**

In compliance with the order dated 17/9/2004 of the Hon'ble High Court of Punjab and Haryana in CWP Nos 13556, 13663 and 13721 of 2004 , and in supersession of the admissions/counselling notice dated 10/9/2004 issued by the Baba Farid University of Health Sciences, Faridkot , it is hereby notified :

- (1) That the counselling already held from 13/9/04 to 17/9/04 in private Dental Colleges pursuant to the admission/counselling notice dated 10/9/2004 issued by the University shall stand cancelled and no effect shall be given thereto.
- (2) That the counselling for BAMS course scheduled for 20/9/04 and 21/9/04 shall also stand cancelled.
- (3) **Schedule** : That fresh counselling for the BDS and BAMS courses against seats in the Management Quota in private institutions shall be held as under -

(4) **Terms/Conditions:** The fresh counselling shall be strictly subject to the following terms and conditions :

- (a) The eligible candidates shall apply on the College Admission Form to the College/ Colleges concerned by 22/9/04, after which date no application shall be entertained.
- (b) The College Admission Forms shall be available in the respective colleges (i.e. in the college for which the candidate wants to apply) and in Baba Farid University, Faridkot (for all colleges ) from 20/9/04 to 22/9/04 at least from 9:00 AM to 6:00 PM.
- (c) The Admission Form duly filled in shall be submitted to the college/colleges concerned from 9:00AM to 6:00 PM from 20/9/04 to 22/9/04. The colleges shall keep a special counter open to receive the Forms on each of the said dates from 9:00 AM to 6:00 PM. In view of paucity of time , the candidates are advised in their own interest to submit the Form(s) by hand.
- (d) The candidates may make two photocopies of the duly filled in Admission Form. One photocopy may be submitted to the Registrar, Baba Farid University, Faridkot. The other photocopy may be retained by the candidate for record and carried by him/her at the time of counselling. The photocopy shall be proof of submission of the Admission Form.
- (e) Candidates who have already submitted their Admission Forms to the College(s) and/or to the University need not apply again, but it shall be the obligation of the concerned candidates/applicants to confirm the said fact. However, candidates who had applied earlier directly to the University on plain paper (and not in the application forms prescribed

by the respective College(s) in its prospectus) shall have to apply afresh on the prescribed form as detailed above.

- (f) Each college shall prepare a merit list as per PMET – 2004 merit of the applications received, display the same on its Notice Board and send a copy thereof to the Registrar of the University. This shall be done by the Colleges on 23/09/04 and 24/09/04. While preparing the merit list the College(s) shall include applications already received by the college/university as per clause (e) above.
- (g) The final merit list of Admission after counselling shall be displayed by each College on its Notice Board and a copy thereof shall be sent to the Registrar of the University on the same day.
- (h) The successful applicants shall be given Admission Cards by the Selection Committee forthwith. However, they will be given three days time to deposit the fee with the College. The fee can be paid by bank draft or by cash against receipt.
- (i) **Dashmesh Dental College, Faridkot-** Students of this College who have already been admitted, would also be at liberty to submit fresh applications for admission to any other College with a copy to the University. Other candidates higher in merit than those already admitted to this College, if they opt for seats in this College and are granted admission by the Selection Committee, would be admitted to this College. Candidates already admitted to this College who would be displaced by admission of such candidates, shall be entitled to refund of full fee forthwith. Accordingly, the students already admitted in this College are advised in their own interest to submit fresh applications for admission to any other college as detailed above.
