Please refer to the meeting held under the Chairpersonship of Secretary ICHAP on 12.07.2023 at 03:00 PM with States/UTs regarding the non-constitution of the State Councils under National Commission for Allied and Healthcare Professions (NCAHP) Act, 2021.

As you are aware that National Commission for Allied and Healthcare Professions (NCAHP) Act, 2021 (notified on 28.03.2021) came into force on 25.05.2021. As per Section 22(1) of the NCAHP Act, 2021 "every State Government shall, by notification, within six months from the date of commencement of this Act, constitute a State Council to be called the State Allied and Healthcare Council for exercising such powers and discharging such duties as may be laid down under this Act". At present the date for same has been extended up to 25.11.2023 vide Notification dated 18.05.2023. The formation of State Council is being monitored actively by the Prime Minister's Office and also by the Parliamentary Standing Committee on 'Quality of Medical Education'. It is therefore again requested to expedite the formation of state council.

Further, your kind attention is brought to DO letter No. P-16016/19/2022-ICAH(Pt.1) dated 29.06.2022 (copy enclosed) requesting you to furnish the available details of allied and healthcare institutions in your State/UT in given format (copy enclosed). The desired information is yet to be received from your State/UT. It is also highlighted that consolidated data from your State/UT has to be provided to the ICAHP (icahp.india@gmail.com) in the prescribed format as enclosed. You are therefore requested to appoint a Nodal Officer from the State for further communication with ICHAP in this regard.

As you are aware that, the National Commission for Allied and Healthcare Professions Act, 2021 provides for regulation and maintenance of standards of education and services by allied and healthcare professionals, assessment of institutions, maintenance of a Central Register and State Register and creation of a system to improve access, research and development and adoption of latest scientific advancement and for matters connected therewith or incidental thereto.

2. In this regard a data base of the allied and healthcare institutions is being prepared. An Allied and healthcare institution has been defined as an educational or research institution which grants diploma or undergraduate, postgraduate or doctoral degree or any other post degree certification in any allied and healthcare profession under this Act. Fifty six allied & healthcare professions have been scheduled under the Act (copy enclosed).
