**No. G.S.R. 50/P.A.42/1963/S.54/Amd./2023.**-The following draft of rules further to amend the Board of Ayurvedic and Unani Systems of Medicine (Employees Conditions of Service) Rules 1976, which the Governor of Punjab proposes to make in exercise of the powers conferred by section 54 of the Punjab Ayurvedic and Unani Practitioners Act, 1963 (Punjab Act No.42 of 1963), and all other powers enabling him in this behalf, is published as required under sub-section (1) of section 54 of the said Act, for information of the persons likely to be affected thereby.

Notice is hereby given that the draft will be taken into consideration by the Government on the expiry of a period of thirty days from the date of publication of this notification in the Official Gazette, together with any objection or suggestion, which may be received by the Additional Chief Secretary to the Government of Punjab, Department of Medical Education and Research, Room No.16, 5th Floor, Punjab Civil Secretariat-I, Sector 1, Chandigarh, from any person before the expiry of the aforesaid period, with respect to said draft, namely: -

**DRAFT RULES**

1. (1) These rules may be called the Board of Ayurvedic and Unani Systems of Medicine (Employees Conditions of Service) (Amendment) Rules, 2023.  
(2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Board of Ayurvedic and Unani Systems of Medicine (Employees Conditions of Service) Rules, 1976 (hereinafter referred to as the said rules), in rule 2, in sub-rule (1), for clause (j), the following clause shall be substituted; namely: -  
“(j) ‘subscriber’ means an employee, who is a subscriber to the Employees Provident Fund.”.
3. In the said rules, in rule 21, after the first proviso, the following proviso shall be inserted, namely: -  
"Provided further that the Registrar shall retire on attaining the age of sixty-five years."

4. In the said rules, in Appendix 'B', -

(i) for rules 5,6,7 and 8, the following rules shall be substituted namely:-

**"5. Payment of subscriptions and contributions to be made monthly to the Employees Provident Fund Organisation.-** The Board shall open an account to be called the Board of Ayurvedic and Unani Systems of Medicine Punjab Employees Provident Fund Account with the Employees Provident Fund Organisation and as soon as may be at the beginning of each month, but not later than the fifteenth day of each month, shall pay into such account, the amount of all subscriptions deducted under the provisions of rule 2 and of the contributions payable under the provisions of rule 3.

**6. Mode of Payment.-**The Board shall make the payments of the provident fund amount to the Employees Provident Fund Organisation through online portal of the said Organisation .

**7. Subscriptions.-**The payment under the provisions of rule 6 shall be drawn in favour of the subscriber.

**8. General rules of withdrawals.-**The amount from Employees Provident Fund account shall be withdrawn from the said account of the subscriber after intimating the Board and after fulfilling the conditions laid down by the Employees Provident Fund Organisation, from time to time."; and

(ii) rules 9, 10 and 11 shall be omitted.
